You may pay by **cash**, **check**, or **money order** (made payable to Nash County) by **mail**, or **in person** at Nash County Administration Building - Public Utilities Department. (Debit/Credit cards also accepted)

Submission of this application is a commitment by the applicant to the County System and is nonrefundable unless the County is unable to provide service. The tap fee and/or tap automatically transfer with sale/conveyance of property.

Once the water tap is installed, we will start billing you monthly according to our fee schedule, currently a base rate of \$20/month. Once a meter is set, (whether you connect to the service tap or not), the monthly billing will include the base rate of \$30 plus usage cost per our fee schedule.

Nash County guarantees minimum pressure/volume at each customer's water meter. Many factors (size of water main and/or service, demand, distance, elevation, number of plumbing fixtures, etc.) influence the final water pressure you get in your home. Due to these factors, pressure/volume cannot be guaranteed at any given point beyond the meter or at any given fixture in your home. These issues should be discussed with your plumber to determine the required tap size and the size of the service from the meter to your home.

ADDITIONAL APPLICATIONS & FEES

- The “**Application for Water/Sewer Service**” Form and **Additional fees** are required prior to your connection from the tap to your home. Fees include a **\$20** service initiation fee and a deposit fee ranging from **\$0 to \$100** (each service), depending on your credit history.
- Also at your expense, a plumbing permit from Nash County Inspections and the plumbing work on your property must be secured to the point of connection (County meter usually at the street right-of-way) with any additional improvements as required by the plumbing code.
- Please verify well location, property lines & other setbacks with your contractor before work begins.

The following information is requested by the Federal Government in order to monitor compliance with Federal laws prohibiting discrimination against applicants seeking to participate in this program. You are not required to furnish this information, but you are encouraged to do so. This information will not be used in evaluating your application or to discriminate against you in any way.
